The Greater Kansas City Dog Training Club offers a Certificate to each successful team in these tests.

Entry fees & forms: \$110.00 (includes an AKC \$ 0.50 recording and \$3.00 service fee). No entry fees will be refunded except for an entrant that pulls before the closing date; or an entrant and/or alternate that does not participate when another alternate is present to replace him prior to the track draw on the day of the test. Make checks payable to **GKCDTC** and mail with entry fee to: *Christine Lero, Test Secretary, 702 SE Douglas St., Lees Summit, MO. 64063*

Entries will not be accepted without fees and must be on an Official AKC form that includes the reverse side of the form. In the event that you enter more than one dog, please send a separate check for each entry. When using the club's "Test Worker Option" please include a valid test worker certificate with the entry. **Returned Checks do not constitute a valid entry fee. The Trial Secretary may add a fee to each returned check.**

No entries will be accepted which require a signature for delivery.

Closing date: Entries for this VST Test close on Thursday, March 8th, 2018 at 5:00pm at the home of the Secretary. After that time entries cannot be accepted, canceled, altered, or substituted. Changes, additions, or corrections to entry forms must be received in writing (US Mail or email is acceptable) prior to close of entries. Those received by telephone or fax are not acceptable.

Drawing of entries for the test: A drawing will be held at 6:00 pm, Thursday, March 8th, 2018, at the Secretary's home, 702 SE Douglas St, Lees Summit MO 64063, to fill entry limits of 5 tracks. If the limit is not reached, the draw is optional. *The drawing is open to the public, all are welcome to attend.* The drawing, conducted by the test secretary, shall be completely at random, except preference will be given to those entries that have not earned a VST title. The test worker draw option as allowed by AKC Tracking regulations, Chapter 1, Section 13(d) will be used in this test for workers as defined and published as Club Policy in the club's minutes and newsletter. Following the draw, the test secretary will attempt to contact all entrants and advise them of the outcome within 48 hours. E-mail & phone inquiries to the secretary after the draw are welcome. Upon notification, alternates shall have the option of accepting or refusing the opportunity to participate in the test. In the event an accepted entry is absent on the day of the test, the first alternate entry present according to the order in which they were drawn shall assume the vacant position.

Bitches in season: *Tracking Regulation Chapter 2 Section 8.* Bitches in season may participate. The test secretary and judges are to be notified prior to the drawing for running order on the day of the test. The last track laid shall be reserved for the bitch in season. If there is more than one bitch in season, a second draw of the last tracks will be held for these bitches.

This test is limited to AKC Purebred Dogs only, and will not be open to AKC All American dogs.

THE GKCDTC Inc, the test secretary, test committee, etc. assumes no responsibility for loss, damage, or injury sustained by spectators, exhibitors, exhibitor's property, and their dogs.

GKCDTC and the AKC believe that the well being of dogs and the participants is of utmost importance. If the test can not be held and/or completed by reason of riots, civil disturbances, public emergencies, act of public enemy, strikes, or other acts beyond the control of the GKCDTC, the GKCDTC reserves the right to cancel and/or stop the event before completion. No refunds of entry fees will be made.

Arbitration: The Greater Kansas City Dog Training Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Coffee, juice and breakfast items will be available prior to the draw.

The GKCDTC test committee and judge wish to invite you to join us for lunch following the test. We will be meeting at a local near-by restaurant for a “dutch treat” meal. Information will be available at the draw the morning of the test. Please plan on joining us!

THE TEST SITE IS PRIVATE PROPERTY. TRAINING ON THE TEST SITE IS NOT ALLOWED.

The GKCDTC has permission to use the site for the weekend of the test only. Loss of the site for future events may be in jeopardy if anyone violates this rule. Any person(s) caught trespassing may be prosecuted by the property owners, to the full extent of the law. In addition, any person(s) training on the site will be subject to disciplinary action by the GKCDTC and/or the GKCDTC test committee.

Dogs must be on lead at all times in Overland Park and in any area of the tracking site during test hours.

Directions to the draw site:

From I-35 North: Travel south and take US-69 south via Exit 225B. Take the 135th St exit, turn left (east) on 135th St. Go 1 mile, turn right on Metcalf. The Phillips 66 is on the West side of Metcalf, behind Capital Federal Bank.

From I-35 South: North to Santa Fe exit, (Exit 218). The Santa Fe East ramp merges onto East Santa Fe. East Santa Fe becomes 135th St, turn right onto Metcalf, The Phillips 66 is on the West side of Metcalf, behind Capital Federal Bank.

From I-435 Westbound: To the Metcalf exit, turn left on Metcalf, follow to 135th Street, go through the intersection, turning the first right into the parking lot.

From I-435 Eastbound: **To the** Metcalf exit, turn right on Metcalf, follow to 135th Street, go through the intersection, turning the first right into the parking lot.
