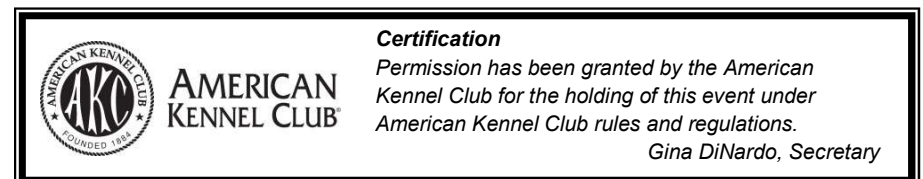

NOTICE TO EXHIBITORS

The safety of the dogs is our primary concern.

Please read and follow the following rules and regulations:

By entering this trial, exhibitors are acknowledging that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform the exercises safely.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing club. Greater Kansas City Dog Training Club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

Entries not on official AKC forms or photocopies of entry forms without the Agreement and Rules on the reverse side are not acceptable.

There will be a \$25.00 service charge for any returned checks. Returned checks do not constitute a valid entry fee. Faxed, telegraph, telephone, email and unsigned entries cannot be accepted. Entries will **not** be accepted which specifies any conditions as to their acceptance.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Owners are responsible for errors in making out entry forms and no entry fee will be refunded for such errors or cancellation of entries after the published closing date. A **recording fee** of \$.50 and a **\$3.00 AKC event service fee** will be required for each dog entered at any Licensed or Member Club Show or Obedience Trial. These fees are to be collected by the show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, these fees are to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2)

Dogs need to be present only for scheduled judging. Consult the judging program for time of judging. **Judges are not required to wait for dogs.** They will adhere as closely as possible to the Judging Schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when the class is to be judged. The show-giving Club and the Trial Secretary have no obligation or responsibility for providing service through the public address system, runners or stewards for the purpose of calling or locating dogs that are not brought into the ring when required.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitors whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees will be made.

Bitches in season are not permitted in the trial. Entry fees less \$10/day administrative fee and applicable AKC recording fees per day will be refunded for bitches coming in season after closing date. Owner must present certificate from veterinarian no later than one half hour prior to the start of the first class in the trial.

All dogs must remain on leash or kenneled unless showing in the ring.

Exhibitors are to clean up, inside/outside of the building, pertaining to their dog(s).

NO SMOKING inside building.

NO ALCOHOL permitted on show grounds.

NO FIREARMS permitted on show grounds.

NO GLASS CONTAINERS of any kind are allowed in the facility.

All present are asked to refrain from using audible cell phone ringers in exhibition area.

No Crating by the rings, all crates to be in the designated crating area.

Crating is severely limited. Please stack crates as much as possible and use a mat under all crates. Reserve crating space will be allocated for workers who sign up to help on a first received basis. Submit form with entries to volunteer.

Building will be available for setup at 3 pm on Thursday, March 22, 2018

No unentered dogs allowed.

Directions to the Show Site

Please be aware that most navigation devices do not know the correct location for All Star Dog Sports! It is advised that you look at a map and find the location before trusting GPS.

The site is located south of the city of Blue Springs on Highway 7, **just south of the intersection of Hwy 7 and Wyatt Rd, on the west side of Hwy 7.**

From the North (I-70): The site is 4.8 miles south of the intersection of I-70 and Hwy 7 and immediately past Anderson Rentals.

From the South: The site is 1.4 miles north of the intersection of Hwy 7 and Colbern Rd. or 5.3 miles north of the intersection of Hwy 7 and Hwy 50 and north of LockBox Storage. Hwy 7 is divided by a median so it will be necessary to drive north of the site and make a U-turn at Wyatt Road.
